Criminal Justice and Forensic Science Students visit Washington D.C.

fter a semester and a half of hard work and fundraising, the members of the Criminal Justice and Forensic Science Association, were able to take a trip to Washington D.C. April 16th through the 19th. On Friday April 17th, the association members went to the National Museum of Crime and Punishment. The mission of the Crime Museum is "To provide guests of all ages with memorable insight into our nation's history of crime and its consequences, law enforcement, forensic science, and crime scene investigation through a captivating, interactive, entertaining, and educational experience." The best part of the Crime Museum is that everything within the museum linked back to classes that students have taken throughout their time spent at Hilbert College.

Following the museum visit, students were allotted free time for the rest of the day and evening. Most chose to walk through the city to the National Mall to observe all of the monuments. There was an Earth Day concert being sound checked next to the Washington Monument, where students soaked up some sun and listened to some popular artists such as Mary J. Blige, Fall Out Boy, and Usher. Next on their list of monuments was the Lincoln Memorial and on the way students met up with a Hilbert Alumni who is now working in D.C. They took some group photos and then went to see the Jefferson Memorial as well as the Vietnam Veterans Memorial.

After lunch, the group split up and some went to the Holocaust Museum, Pentagon City Mall and



rested by the pool back at the hotel while the others went to see the White House and Georgetown. In Georgetown, they did some shopping and went on a walking ghost tour of the town. The ghost tour was packed with many stories about prestigious families that many grew up learning about and their past within Georgetown. The tour ended at the steps from the movie The Exorcist. By the time the students got back to their hotel they were exhausted from walking a total of 20 miles in one day, but they did not let this hold them back from doing it all over again on Saturday!

Saturday, one of the groups went to the Smithsonian to visit the Natural History Museum and the American History Museum, while the others went to visit the Pentagon to observe the memorial and Arlington National Cemetery to see John F. Kennedy's Gravesite, the Tomb of the Unknown Soldier, Changing of the Guard at the tomb, the Memorial Amphitheater and the 9/11 Exhibit.

Later Saturday evening, the group met up for dinner at a restaurant in Falls Church, Virginia. After dinner the group split again, a few went out on the town to experience the D.C. nightlife, others went to observe the monuments in National Mall at night, and the other half went on the Georgetown ghost tour.
