# Hilbert student-created cybercrimes program included in CSI Exhibit

Area families will have a chance to test their cybercrime investigation skills while learning about digital forensics and internet safety, including cyberbullying prevention, at an educational program being presented by two Hilbert College students as part of a new Buffalo Museum of Science exhibit., created in cooperation with the hit CBS television franchise, includes a "Digital Forensics and Internet Safety" program developed by Hilbert forensic science/crime scene investigation majors Kelly Bigaj and Jessica Anderhalt.. Scheduled for several sessions throughout the three-month long interactive exhibit in Buffalo, this is the first time an educational program specifically on digital crime has been incorporated in the exhibit since the national tour began in 2007.

Under the guidance of Hilbert adjunct instructor **Deborah Mogavero**, the student-designed program is focusing on digital forensics and crime related to social media, mobile platforms and Web-based technologies, including Facebook and smartphones.

"With the internet and mobile technologies so pervasive today, this is an important topic that's pertinent and useful in the daily lives of many Western New Yorkers," said Mogavero, who teaches a forensic science course on "Computer Crime Investigation.. "Being involved in the exhibit's educational programming offers the students a unique learning experience outside the classroom.", she said. "It's added to their knowledge base on digital crimes and has helped them gain practical skills

that will be valuable in the professional field."

Bigaj, a Lackawanna resident who is in her junior year at Hilbert, explained that "whether it's computers, cell phones or other electronic devices, technology can be used in various harmful ways by individuals with bad intentions," she said. "Children are particularly vulnerable to being victimized so one of our goals is to educate parents on what they can do to protect their entire family."

"We wanted to open people's eyes about cybercrimes," added freshman Anderhalt, who resides in Hamburg. "Social networking sites like Facebook, have become very popular with younger children who may not be as aware of the risks of posting personal messages and photos online.

**Professors Linda Bernstein and Martin Floss** co-authored a chapter in an edited book titled "Contemporary Issues in Criminal Justice". The Chapter is titled, "Examining the Quality and Effectiveness of a County Juvenile Treatment (Drug) Court." Dr. Floss also has an article being published in The Encyclopedia of Criminology and Criminal Justice, by Wiley-Blackwell publishers and Edited by Jay Albanese, titled, "Reliability."

**Professor Donna Zimpfer** is scheduled to conduct a review of the Criminal Justice Program at Jamestown Community College. Professor Zimpfer is a graduate of JCC and looks forward to re-visiting her alma mater in this new role.

**Professor Bernard Walsh** is collaborating with Tim Murphy a former Niagara County District Attorney, illustrating baseball fields across New York State. The book will be titled appropriately "The Fields of New York" and will show pictures and the history of each park from Yankee Stadium to Hilbert College baseball and softball fields and many other locations in between. The book is nearly completed and a publisher has been contracted. It is noted Mr. Murphy frequently lectures at Hilbert regarding Environmental Law and Organized Crime.

In addition, **Professor Walsh** is conducting research for a book discussing a true story of espionage, theft of U.S. government classified documents, romance and death. The events described in the book took place in Washington D.C., North and South Vietnam and Paris France. This FBI investigation occurred between 1975 and 1977 and was experienced by the author.

**Professor Edward Drabczyk, Adjunct Faculty** member in Criminal Justice recently completed three safety and security presentations to ninety seniors at the Catholic Health –Living Independently for Elders in Lackawanna. # **Institute for Law and Justice News**

The US Attorney's Office, Western District of New York, the Erie County Law Enforcement Foundation, Inc., Hilbert's Criminal Justice Studies Division and the Institute for Law and Justice sponsored several conferences during the past few months.

On March 15, 2012 Hilbert College's Institute for Law and Justice cosponsored a seminar on Law Enforcement Leadership. Over 200 local, state and federal law enforcement officers packed Swan Auditorium to take part in a lecture and interactive exercises highlighting police leadership scenarios. The main presenter was Stephen Gower of the Gower Group in Atlanta, Georgia. Mr. Gower is a renowned author and speaker on the topic of leadership roles in life and professional roles. Our own **Barb DeLaRosa** did a fantastic job in providing administrative support during the organization of the event and the day long program.

In addition the institute will be cosponsoring two more trainings for law enforcement this spring. On May 24th there will be a Cyber Security training and on June 5th a seminar on Domestic Terrorism. Both seminars are being cosponsored with the US Attorney's Office and the Federal Bureau of Investigation. This will again attract about 150 law enforcement officers for each event.
