100 Club Recognizes Officers


The 100 Club of Buffalo recognized Evans Police Lt. Bradley DiMartino and Officers Jeffrey DeVinney and Greg Szarowicz as well as Highland Hose Fire Company Lt. Philip Schott for their quick and decisive actions of July 30, 2015 which saved the life of an 11 year old child and one of their own.

During the early evening of July 30, 2015 Evans Police Officers, Lt. Bradley DiMartino, Officers Greg Szarowicz and Jeffrey DeVinney as well as Highland Hose Fire Company Lt. Philip Schott responded to a call of swimmers in distress in the waters of Lake Erie at Wendt Beach Park. Upon arrival they were apprised of the fact that a woman and two young girls were in the Lake Erie waters. They were also greeted by 25 MPH winds and 5-6 foot rolling waves coming in 3 to 5 second intervals making it difficult to spot the victims in the water. Lt. DiMartino, finally spotted the head of one of the victims, an 11 year old girl, bobbing in the water about 100 yards offshore.

Without regard for his safety, Lt. DiMartino removed his gun belt and entered the water in an attempt to rescue the girl. He later stated that he has been swimming in Lake Erie since he was a young boy and has never encountered such pounding waves and undertows and if not for Officers Szarowicz and DeVinney along with Firefighter Schott, he may have become a victim himself. Lt. DiMartino stated that the waves kept crashing over him knocking him to the lake and the undertow felt like a vacuum but he was determined to reach the young victim. When he did he was thoroughly exhausted and had to pass her off to Officer DiVinney who along with Officer Szarowicz and Firefighter Schott

assisted both DiMartino and the girl to shore where she was throwing up water. The other girl was able to make it to shore without assistance and the rescued child's mother unfortunately drowned in an attempt to save her daughter.

The two girls were eventually transported to and treated at Woman's and Children's Hospital where they were reported to have made full recoveries.

Police Department Promotes Two to Lieutenant

Patrick Rizzo, (AA'96 and BS '97, CJ) and David Bowersox, (BS '97, CJ) have new titles to get used to now that both patrol officers have been promoted to lieutenants in the Orchard Park Police Department.

The promotion became official during the April 6 Town Board meeting.

Police Chief Mark Pacholec said one lieutenant had previously retired and the Town Board authorized an additional lieutenant last year. The department now has five patrol lieutenants and one detective lieutenant. Pacholec added that once the positions are approved, a call is made to civil service for a list of those who have taken the test for lieutenant.

From there, interviews by the command staff

are conducted, along with looking at the individuals' performance and records. The officers are then ranked by who is believed to be the best choice.

"Both of these gentlemen have been here for 14 and 17 years, respectively," Pacholec said. "Both have been field training officers, which means they're training and supervising our new officers out at the academy."

Bowersox and Rizzo both graduated from Hilbert College.

Bowersox has served in the U.S. Army and Air Force Reserve. Rizzo is a former University at Buffalo police officer.

Both men also had additional special skills, according to Pacholec.

"They bring a lot to the table; the performance

has been exemplary," he said.

Bowersox, an officer in the department for 14 years, said he's excited about the promotion. "I'm looking forward to the new change in my career," Bowersox said. "It's going to be a learning process, but it's also going to be a new challenge."

Rizzo, who has been an officer for 17 years, said there's a mix of excitement and anxiety. "It feels like a new job, so there's excitement and anxiety, but it's good," Rizzo said. "You don't want to mess up."

Pacholec said the two men will have the ability to authorize time off, purchasing and training. "It's a matter of learning the procedures and processes," he said.
